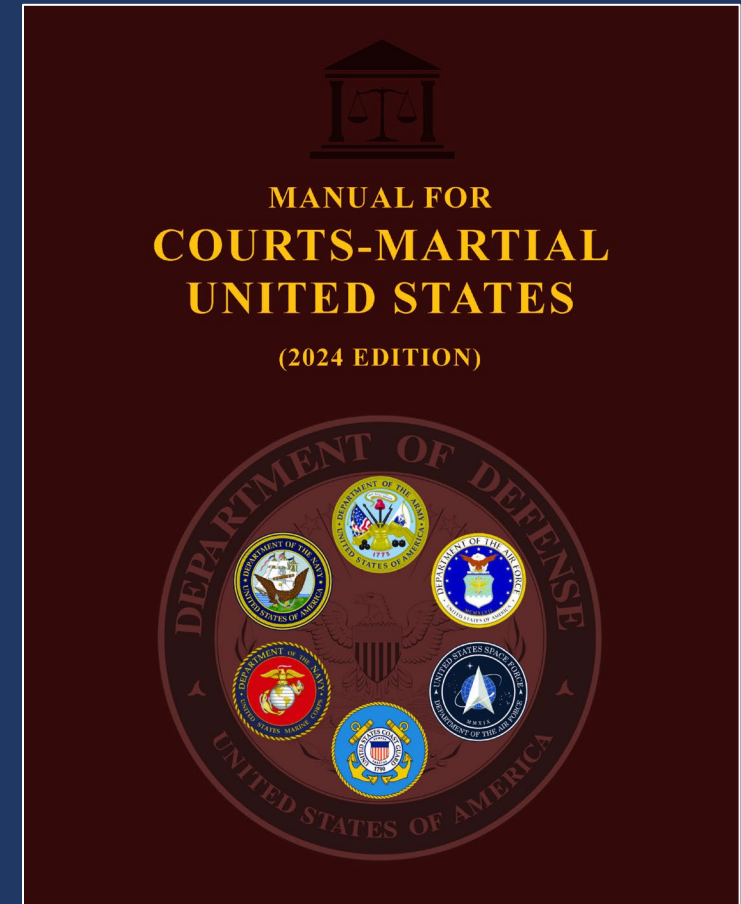

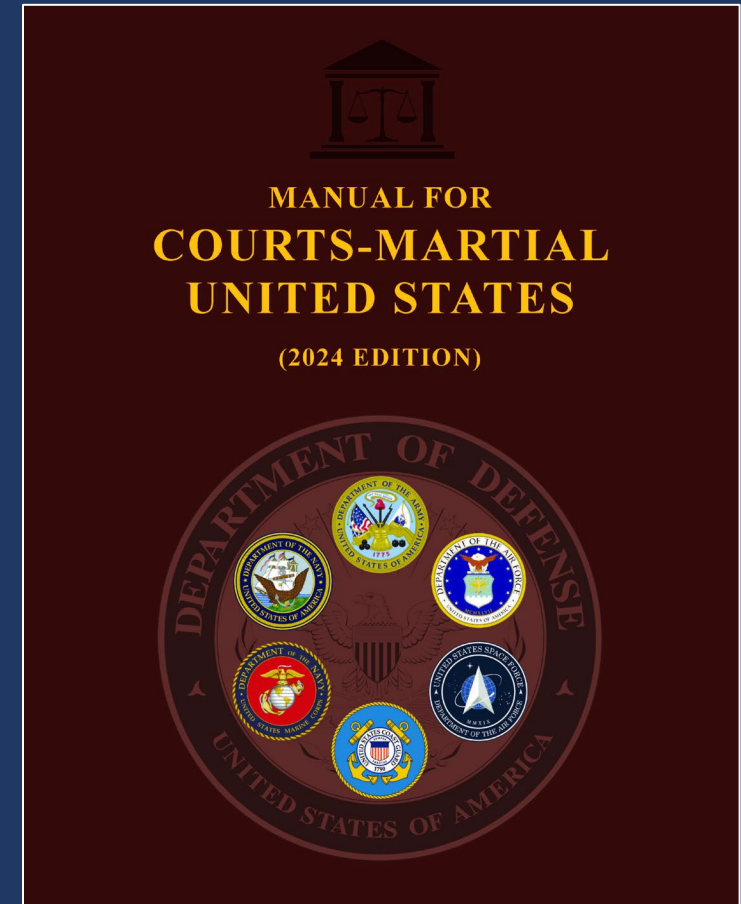

### 20 Recommendations, 21 Findings

- Improve Data Collection and Public Access to Court-Martial Records
- Amend Art 117a, UCMJ “Wrongful broadcast or distribution of intimate visual images”
- Clarify responsibilities for criminal sexual harassment
- Better handling of complaints of domestic violence and retaliation
- **Areas of concern: plea agreements and specified sentences**

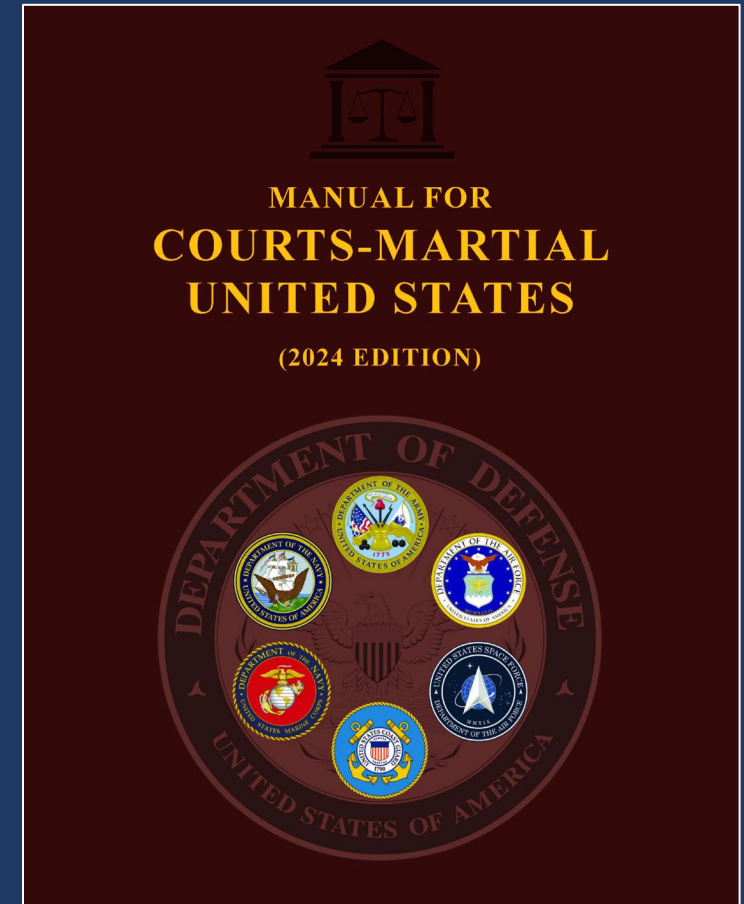

January 2025

- Formalize uniform standards for removal of LSTC to ensure due process
- Amend Article 37 and RCM 104 to ensure the rules prohibiting unlawful command influence account for the new OSTC
- Consider changing the LSTCs' reporting chain



# The Military Justice Review Panel



## Assessment of Article 32, UCMJ, Preliminary Hearings

- Issued December 28, 2023
- Recommend Congress amend Article 32 to:
  1. Allow for a reasonable level of discovery while retaining victim protections
  2. Require a certification process for the preliminary hearing officer
  3. Preclude referral if the preliminary hearing officer determines that a charge lacks probable cause
    - Subject to a right of appeal to a military judge and without prejudice to the government referring the charge anew



# The Military Justice Review Panel



## Judicially Issued Military Protective Orders

- Issued April 19, 2023
- Recommend against authorizing judicially issued MPOs as part of the military justice system
- Provide additional education on obtaining protective orders in local jurisdictions
- Explore options for expanding victims' counsel's representation and assistance through the Expanded Legal Assistance Program



# The Military Justice Review Panel



## Restitution as an Authorized Portion of a Court-Martial Sentence

- Issued January 19, 2023
- Decline to endorse the recommendation of the 2021 Independent Review Commission on Sexual Assault in the Military (IRC) that restitution orders be authorized as part of court-martial sentences
- Study other ways to compensate victims for limited out-of-pocket expenses incurred as a direct result of a Service member's crimes

#### About the Panel:

Composed of thirteen military veterans with broad experience in military justice and criminal law, the Military Justice Review Panel (MJRP) is a permanent blue-ribbon panel chartered pursuant to Article 146, Uniform Code of Military Justice (UCMJ). An essential component of the military justice system, the MJRP is the only panel statutorily created by the UCMJ.

The heart of our work is conducting independent assessments of the military justice system. To carry out our statutory duties, Congress has authorized the MJRP to request information from federal agencies, hold hearings, take testimony, and receive evidence.

Our reports, submitted periodically to the Committees on Armed Services of the Senate and the House of Representatives, provide comprehensive findings and recommendations based on our reviews and assessments.
